Personal data I process

Ferenc van der Velde processes personal data because you use one of his services and/or because you supplied your personal data to him yourself.

The following personal data is collected:

Special and/or sensitive personal data

The website and/or services of Ferenc van der Velde do not collect any special or sensitive personal data nor do they collect data of website visitors younger than 16 years old. The purpose and basis of the personal data processing

Ferenc van der Velde processes your personal data for the following purposes:

Automated decision making

Ferenc van der Velde does not take decisions based on automated processing that can have (significant) consequences for people.

How long I keep your personal data

Ferenc van der Velde doesn't store your personal data for longer than is strictly necessary to realise the purposes for which your data is collected. I use the following retention period for the storage of personal data:

To comply with tax laws I store the basic personal data (name, address, phone number, email and bank account number) for seven years.

Sharing personal data with third parties

Ferenc van der Velde shares your personal data (name, address, phone number, email and bank account number) with his accountant for administration purposes. Ferenc van der Velde only shares your personal data with other third parties when this is necessary for the execution of our agreement or to comply with legal obligation.

Cookies and/or similar techniques

Ferenc van der Velde does not make use of any cookies and/or similar techniques.

Review, change or delete your data

You have the right to review, correct or delete your personal data. In addition you have the right to withdraw your permission for Ferenc van der Velde to process your data and you have the right to transfer your data to you. I will respond as soon as possible, but within 4 weeks at your request.
